DEPOSIT

The School will reserve a place for your child when it has received a **deposit of \$1,250** (checks and all credit cards except American Express may be used to pay this fee). This fee is non-refundable and deducted from your outstanding tuition balance. It will hold Student's place until the 1st tuition payment is due. Parent is obligated to pay the full tuition and fees for the year notwithstanding the fact that the Student does not attend Thacher for all or part of the year.

PAYMENT PLAN OPTIONS

Please note that all before school care and after school care drop-in charges will be billed through and payable directly to the school.

ADDITIONAL TERMS

Financial Obligation: If the parent/guardian (parent) makes a deposit and wishes to withdraw the Agreement before June 1st, the deposit will not be refunded, but there will be no further obligation. If a family new to the school decides to withdraw from the school during the first thirty calendar days of the school year, the family's only financial obligation to the school will be the non-refundable deposit as well as a percentage of tuition equal to the percentage of days in the school year up to the day of the requested withdrawal. After the first thirty days of the school year, the obligation of the parent(s) to pay all costs for the full academic year is unconditional. No portion of such costs so paid or outstanding will be refunded or canceled, notwithstanding the absence, withdrawal, or dismissal of the above student, regardless of whether the vacated position is filled by another student. However, if, in the sole opinion of Thacher Montessori School's Board of Trustees, it is determined that Thacher does not provide a suitable environment for the child's educational progress, the family's only financial obligation to the school will be a percentage of tuition equal to the percentage of days in the school year up to the day of the requested withdrawal.

An account is considered delinquent if not received by the fifteenth of the month. A late payment fee of \$15 will be charged per month on a delinquent account. In addition, Smart Tuition will charge \$30 for their effort in collecting past due amounts. Fees remaining unpaid for more than two months without prior approval of the Board of Trustees may result in the dismissal of the above-named student. The School is entitled to be reimbursed for any attorney's fees and other costs incurred in the collection of any unpaid balance.

The parent(s) agree(s) to accept Thacher's educational programs, any modifications made to those programs, as well as Thacher's rules and regulations as set forth in the Thacher Montessori School Family Handbook and Student Handbook (if applicable) and any letters articulating Thacher policy from its Head of School. The parent or student's disregard of the basic principles of conduct may be deemed sufficient cause for dismissal. Thacher Montessori School reserves the right to terminate enrollment of a child at the sole discretion of the School's Board of Trustees and Head of School. The parent(s) agree(s) to have the child arrive and be picked up at the appropriate arrival and departure times, as indicated in the Family Handbook and this contract. The parent(s) agree to pay drop-in before care and/or after care charges that are otherwise incurred.
